



2022 NSW SUPERSPRINT CHAMPIONSHIP SUPPLEMENTARY REGULATIONS

PART 2

2.1 Two Competitions

These Supplementary Regulations are for a single event that includes two (2) competitions, which are a State Competition being a Round of the NSW State Supersprint Championship ("the Championship") and a Club Competition being a Club Supersprint ("the Club Supersprint"). All of the Supplementary Regulations apply equally to both competitions with the exception of those regulations that specifically state that they apply to just one or the other.

2.2 **Date:** 27th August 2022 **Day:** Saturday

2.3 Venue: Sydney Motorsport Park, Gardner GP Circuit

Important: As we cannot access the main paddock area before 5:00pm, all competitors are requested to meet at the Amaroo South Circuit paddock area and parking area opposite. Proceed directly to Scrutineering for helmet, log book and proof of vehicle registration at Amaroo South Circuit paddock area from 3:30pm. Secretary of the Event will be at this location until permission to access the Main Control Tower is given.

2.6 Track

Surface: Bitumen / **Length:** 3.93 kms / **Direction:** Anticlockwise / **Boundary:** Drivers who drive off the competition surface as defined by the solid line on the outer edge of the track with all 4 wheels will be deemed to have left the circuit and may have their lap times for that session forfeited.

2.8 Drivers' Briefing

Drivers Briefing Notes will be available electronically to all Competitors, and must be read by no later than the Event Closing Date.

Additionally, a compulsory Drivers Briefing covering key aspects of the day will be held at (time): 4:45pm and (location): Outside Amaroo Circuit Office.

2.9 Number of Laps

Each run will comprise **a minimum time to allow all competitors to complete at least 3 timed laps**, with the time for the fastest single lap being used for results. **The minimum time for each run will be 8 Minutes.** The proposed **minimum number of runs on the day will be: 4**

(Note: The Event will not be concluded when this minimum is achieved. Event will only be concluded early for safety reasons or if no competitors available)

2.10 Entries

- a) Maximum number of Driver entries for the Event: 120 Reserves: 10
- b) Maximum number of Drivers per car 2. Dual entry of drivers in Type 1S will be at the discretion of the organising club.
- c) Drivers must be a financial member of a Motorsport Australia Affiliated Sporting Car Club on the date of the Event.
- d) Vehicles competing in the NSW Supersprint Championship must either be currently road registered (incl. Historic & Classic) and/or be issued with a Motorsport Australia log book.
- e) Vehicles in the Club Supersprint will not be eligible to score Championship points and must run under a competition number in the 900 – 999 range.
- f) Preferential Opening Date for Championship Registrants: Monday 18th July 2022
- g) General Opening Date: Monday 25th July 2022
- h) Entry Fee \$ 240.00 NSWRRRC members, \$290.00 Non Members
- i) Timing Transponder hire if required \$ 17.00 plus GST
- j) Entry Closing Date: Sunday 14th August 2022 Late Entry Closing Date: Friday 26th August 2022
- k) A Late Entry Fee of \$ 25 will apply for entries received after the Entry closing date.
- l) A pit usage fee of \$ 15 per garage (one car space per garage) will apply. Carports \$ Nil .
- m) An entry consists of (1) the submission of an online Event Entry AND (2) the submission of a SSP 09 Motorsport Australia Risk Warning, Disclaimer, Indemnity & Statement of Vehicle Compliance. Entries must contain both submissions and will be accepted in order of receipt electronically together with the appropriate payment as required.
- n) Entries from Drivers between 14 and 18 years of age must have consent signed by a parent or legal guardian.
- o) Vehicles competing in the NSW Supersprint Championship will be issued with stickers denoting their Type. One is to be displayed on the rear window and kept there, if possible, for the entire 2022 season.

2.11 Event Schedule

There will be no in-person document checks. Online form submissions must be received electronically no later than the Event Closing Date and will be checked prior to the event.

Event Start time: 5:30pm

Event Finish time: 10:30pm

2.12 Drivers Code of Conduct

Penalties for breaches of the Drivers Code of Conduct included in SSP 02 Sporting Regulations may apply.

2.13 Scrutineering

- a) Scrutineering/Check-in will commence at 4:30pm and will cease at 6:00pm. No Scrutineering/Check-in will take place during the Drivers Briefing.
- b) A vehicle check must be performed by all competitors whose vehicles do not have a Motorsport Australia Log Book to ensure compliance with the requirements of these Regulations. Vehicles that do not have a Motorsport Australia Log Book will be subject to a random audit after competition commences.
- c) Vehicles that have a Motorsport Australia Log Book will be subject to the Targeted Scrutiny system.

A completed Risk Warning, Disclaimer, Indemnity & Statement of Vehicle Compliance must be submitted online to Organisers no later than the Event Closing Date.

Competitors must first present themselves to Scrutineering with their Log Book and Vehicle Registration (as

applicable) to have their Scrutineering windscreen sticker issued. If the vehicle is not in the Competitors name, an **Automobile Legal Owners Declaration** must be completed by the legal owner and presented at scrutineering. Drivers of double entered vehicles who are sharing the vehicle with the legal owner, are exempt from this requirement.

Please note that scrutineers will conduct random audits of vehicles without a Motorsport Australia Log Book through the day. If a non-compliance is found, the Driver/Competitor may be referred to the Clerk of the Course.

2.14 Road Registered Series Production Electric Vehicles (EV's)

- a) Road Registered Series Production Electric Vehicles with no vehicle electrical system modifications, but with freedoms permitted for Type RR vehicles for suspension, wheels and tyres will be permitted to compete in Class RR4 of the Club Competition only.
- b) All road registered EV's are required to have a Motorsport Australia Log Book, but will have a 2 event moratorium, so that a Log Book Vehicle Inspection can be booked at the first event and carried out at the second event.
- c) The competitor must provide a copy of the EV's Emergency Response Guide to Scrutineering prior in order to obtain permission to compete.
- d) The competitor is to provide a completed Statement of Vehicle Compliance – Electric Vehicle (EV) with their Event Entry.
- e) Each EV competing must have an orange "EV" triangle with white lettering of at least 150mm each side placed adjacent to the competition numbers on both sides of the vehicle.

2.15 Prizes / Awards (Multi Club Supersprint competitors not included)

2.18 COVID-19 Special Conditions

- a) Under no circumstances may anyone attend an event if any of the following apply:
 - a. Have any symptoms consistent with COVID-19 such as higher temperature, respiratory issues, shortness of breath, sore throat, lack of sense of smell, fatigue
 - b. Been in contact with a known COVID-19 positive case in the previous 7 days
- b) Spectators are permitted.
- c) All attendees must comply with NSW Government health and Venue operator requirements
